The Wood Valley Farm consists of 203.87 surveyed acres in Calhoun Co. GA. The property features a well-proportioned mix of hardwood and upland habitat. It has 78.12 acres of 17-year-old longleaf pines, 115.75 acres of mixed hardwood and pine, and approximately 10 acres of food plots. The natural hardwoods provide excellent wildlife habitat for deer and turkey while the upland is a natural element for quail and other small game. It has potential income from the harvest of longleaf pine straw. Perry Creek flows along the western border of the property. Excellent internal road system. Established food plots.
